PCA Advocacy Update

As I write this article, reports are still coming in about the impact the floods have had on our industry in NSW.

Flooding turns to Recovery Phase in NSW

Members have reported crop losses in south western Sydney and on the Mid North Coast of NSW. The PCA are liaising closely with Resilience NSW, the NSW Department of Primary Industries and Local Land Services to assist with the flood response.

Growers in the Sydney Markets are also reporting significant downturn in demand over the last 12 months. Supply chains have also been disrupted due to flooding, road closures and the inability to attract and retain seasonal labour.

National Farmers Federation Horticulture Council

The PCA are currently investigating how joining the National Farmers Federation (NFF) Horticulture Council will benefit you our valued members. There is significant benefit in working with other horticultural peak industry bodies and the NFF to ensure the needs of the protected cropping industry are heard at all levels of government, particularly around labour shortages and other policies preventing the growth of the protected cropping sector.

Protected Cropping Mapping Project-

The PCA have partnered with the University of New England, Cooperative Research Centre for Future Food Systems and Local Land Services in applying for Hort Innovation Frontiers funding to develop a national map of protected cropping systems. This project has taken over 3 years of advocacy, and as discussed in previous articles will provide enormous benefit for our industry including assisting with responses to emergency management and biosecurity outbreaks.

Greenhouse Construction Code Advocacy-

The PCA together with the Hydroponic Farmers Federation (HFF) have written to the Federal Minister for Agriculture David Littleproud about prioritising the need for horticultural buildings to be included in the National Building Construction Code. Contact has also been made with the Australian Building Codes Board.

Review of the Vegetable Industry Strategic Plan

Did you know that the vegetable industry has a Strategic Investment Plan (SIP) that provides the roadmap to guide Hort Innovation grower levies and government contributions? Hort Innovation are calling on all vegetable growers and industry personnel to develop a new refreshed plan for the vegetable industry that guides investment from 2022-2026.

The PCA have already provided input into the berry industry Strategic Investment Plan review and commencing discussions with the nursery and vegetable industries.

AUSVEG together with Hort Innovation are hosting a webinar on the 28 April (3-4pm AEST) and further details are provided in this newsletter.

Many vegetable growers I speak to who currently grow in soil are looking at moving into some form of protection. There is a gap for growers seeking independent information on, but not limited to:

- · Planning regulations and getting started
- Types of growing systems
- Capital costs of various growing systems
- Suitable crops and marketing information

Funding for an Industry Development Manager is critical to socialise these and many other research and development opportunities across many levied commodities including vegetables. The PCA will continue to advocate for this need given the development of the 10-year protected cropping research development and extension strategy that is currently being finalised in parallel with reviews of each individual levied commodity.

Ensuring communication and extension activities truly support business decisions and enhance practices on farm

Horticulture is growing rapidly as an industry in Australia, with a 40 per cent rise in value over the five years to 2017/18 to \$13.2 billion. And that growth is expected to continue, with the sector's farm gate production having the potential to increase to between \$20 and \$30 billion by 2030. To support this growth, it's vital that the nation's horticulture Research and Development Corporation is constantly refining business practices to service levy payers and the industries they work in. In line with that approach, Hort Innovation has launched a new Extension initiative to ensure communication and extension activities truly support business decisions and enhance practices on farm.

What extension activities are currently offered through Hort Innovation?

Hort Innovation is currently working with its partners - such as industry groups, universities and government agencies - to deliver hundreds of projects for horticulture levy payers, of which 80-odd investments are dedicated to extension in the form of industry development and communication, and more than 80 investments also involve extension components.

What is the purpose of Hort Innovation's extension initiative?

The extension initiative enhances the coordination, communication and application of research and development outcomes, and includes a team of Regional Extension Managers, who work in the regions. These managers play a linking role and bring broad coalitions together to share skills and capacity, to solve identified regional problems. Service providers benefit from building their technical and extension skills and knowledge via across industry networks. Collaborative approaches to solving regional problems enable tangible outcomes for growers to use on farm.

Does this service replace other extension activities?

No. Extension activities offered through Hort Innovation are important to the industries they service. The Extension Framework complements and adds to other work to ensure growers have the best possible access to outcomes from their levy investments.

Where are Regional Extension Managers based and what will they do?

Regional Extension Managers operate in six horticulture regions that have been identified for targeted extension, capturing 94 per cent of horticultural activity in Australia by employment and production value.

Maungatapere Berries Expands North In Partnership With Ngāpuhi



Whangārei's premium award-winning berry producer Maungatapere Berries is set to expand its operations into Kaikohe through a partnership with Ngāpuhi Asset Holding Company and Far North Holdings Ltd.

The 28 hectare development at the Ngawha Innovation and Enterprise Park is expected to help meet growing nationwide demand for locally grown healthy fresh fruit.

Co-founder and Director of Maungatapere Berries, Patrick Malley, said the vision for the project is to create a fully sustainable horticulture operation, providing permanent employment and horticultural training opportunities for Kaikohe locals, and using practices such as 'closed-loop' recycling systems, sustainable water usage, biological controls, and precision horticulture.

"However the greatest opportunity is going to be working alongside local iwi on a project of this scale, and providing employment in a region which can really benefit from it.

"Initially, 20 full time positions will be created, and over time we anticipate employing 80 fulltime staff and around 120 seasonal staff," he said. "Roles will range from picking, growing and packing right through to technical, irrigation, management and administration positions."

"Sustainability is a key ethos for our company, across both the environment and our community, and we are always looking at ways to ensure our environmental impact – both short term and long term – is as low as possible whilst also creating long-term career pathways for people in the horticulture industry."

To date, the company has invested heavily in sustainable business practices, including sustainable packaging, biological controls and growing practices as well as careful water management. The company packs its berries in recycled cardboard trays and 100% recycled plastic (RPET) punnets, both manufactured here in New Zealand.

Malley said the Kaikohe site offers an ideal growing climate, ready access to water and proximity to potential employees, making it an ideal location to expand operations.

The expansion in Kaikohe will enable Maungatapere Berries to re-focus its existing Whangārei-based operation on blueberry and kiwifruit production, which will continue to provide an estimated 50 permanent positions and 60 seasonal positions, across the year-long production period.

Development of the first ten hectares of the site is already underway, with the hydroponic growing systems completed during winter and the first production of Maungatapere Berries raspberries and blackberries due to start at the Kaikohe site in November this year. The first ten hectares will be initially grown for the New Zealand market, with the long term potential to develop export opportunities overseas.

Chemical Collection for Queensland Scheduled



Queensland agvet chemicals holders will have an opportunity to safely dispose of their unwanted or obsolete chemicals with a ChemClear collection scheduled for July and August this year. With the recent floods through much of the eastern parts of the country there may be chemicals that have become unidentifiable, making this is a timely service to remove these agvet chemicals from properties and businesses. Following Cyclone Yasi, and the floods that occurred during that event in 2011, over 52,000 litres of agvet chemicals were registered and collected with the assistance of the QLD Government.

Agvet chemical that are part of the drumMUSTER program are collected free of charge, with other chemicals (group 2) incurring a fee for service. Agsafe is working with the QLD Government in a bid to secure funding for the collection of group 2 chemicals to enable farmers and chemical holders to safely dispose of their unwanted agricultural chemicals with minimal cost.

Australian consumers soon to enjoy big flavoursome blueberries



T&G Global is set to take a big bite out of the Australian blueberry market with the first commercial crop of new super-sized, superior tasting blueberries to be launched in retail stores this December.

The global fresh produce company has secured 16 of the latest and best genetics from breeders Plant & Food Research in New Zealand and USA-based Fall Creek Farm and Nursery, and over the last two years has successfully conducted trials of the premium blueberries with selected growers in five Australian states.

Danny Nightingale, T&G's Global Variety Commercialisation Manager says what's exciting about this suite of unique blueberry varieties is their ability to produce fruit all year-round.

"We know Australian's love blueberries, with more than 17,000 tonnes sold each year. With these unique premium varieties we'll be able to grow blueberries all year-round, compared to them currently being available for only approximately eight months," says Danny.

"We're incredibly pleased with the results of our trials, with the blueberries being bigger in size and tasting superior to what's currently available.

"Our commitment to securing the best genetics saw us scour the world to find unique plant varieties which meet consumers' needs, which is what we found in these varieties from Plant & Food Research and Fall Creek Farm and Nursery. Over the past two years we've worked alongside a team of passionate growers in Victoria, Queensland, South Australia, New South Wales and Western Australia to trial them, so it's great to see it coming together, with consumers able to experience them at the end of 2021."

The trials have included a mixture of the new varieties including Cargo, Last Call and Blue Ribbon. It is the first time these varieties have been grown in Australia, for the Australian market.

With 30 hectares already in the ground and producing high quality results, and another 30 hectares soon to be planted, T&G expects volumes to steadily increase in 2021. The blueberries will be sold under T&G's popular premium brand, Orchard Rd.

"This is a game changer for the local berry sector because now we can grow in Australia, for Australian consumers, year round, without the need to import from other countries."

Danny says the new varieties are strong performers and growers are impressed. "They're easier to pick and the yield is significantly higher than other berry varieties, which is great news for growers because they'll get more berries per hectare," he says.
